

Lathrop Co. Inc. Binder No. 142-113

This item comes to the Board with a recommendation for approval from both the planning staff and the planning commission. After discussion it was moved by Mr. Neis that the Board concur in the recommendation of the planning commission, subject to the following conditions:

- (1) That the applicant's engineer certify that the lots have been pinned for each plat or performance bonds in amounts set by the County Commission (based on estimates by the County Public Works Department) be filed with the County Engineer;
- (2) That performance bonds for construction of roads to "county rock road standards" and for the necessary traffic control devices and road (name) signs be filed with the County Engineer in amounts deemed appropriate for each plat by the County Commission (based on estimates from the County Public Works Department); and,
- (3) That statements be placed on the plats concerning the establishment of an agency or agencies for the maintenance of Tract 'A' in Twin Ridge Heights East and Tract 'B' for Twin Ridge Heights West.

Motion seconded by Mr. Cragan, and carried unanimously.

No further business, the Board adjourned to meet on Thursday, August 14, 1980.
