Mr. Dooley then presented the Board a contract for right-of-way for Project No. 23C-1297-01 Formerly 23RS-1528(4), between the Board of Commissioners of Douglas County and Howard H. Hemphill and Elizabeth L. Hemphill, husband and wife, for 2.544 acres of right-of-way easement and 13 rods of fence, in the lump sum of \$2600. This lump sum payment includes allowance for irregularity of fencing, irregularity of boundary, two acres of brome, and abstracting. After review of this agreement it was moved by Mr. Cragan that it be approved, seconded by Mrs. Bradley, and carried unanimously.

At the hour of 10:00 a.m., as advertised, the Board opened bids for the sale of a 1972 GMC, 3/4 ton van, used by the ambulance department. Twelve bids were received. After discussion it was moved by Mrs. Bradley that the Board accept the high bid of F. G. Gouge, Tonganoxie, Kansas, in the amount of \$1200, seconded by Mr. Cragan, and carried unanimously. It should be noted that this van was used by the City of Baldwin in accordance with an Agreement with the City of Baldwin and the Board of Douglas County Commissioners dated May 14, 1979, and has since been replaced with a 1974 Ford as per Agreement of September 22, 1980.
