3rd Quarter
Report

Wayne Kellum, zoning administrator, appeared before the Board to present the Third Quarter Report for 1981 of the transactions which have taken place in his department. Mr. Kellum indicated the issuance of twenty four building permits for new homes or additions to residences with a total declared value to be \$641,000. Permits were issued for six mobile homes with a total declared value of \$47,000 and one commercial for a declared value of \$10,000. One flood plain development permit was issued for a total of \$20. The total estimated value for the three months period is \$698,000 and the total fees collected by his department is \$572. This figure compares to a Third Quarter Report for 1980 of a total estimated value of \$931,275. A copy of this Third Quarter Report will be on file in the commission office.

Phil Leonard, emergency preparedness/risk management coordinator, appeared before the Board to recommend the employment of Kathleen L. Britt, in the position of clerk-typist II, at a salary of \$725.00 per month, effective October 2, 1981. Rev. Sharing:
Allocation is adjusted
for period 13

Ernest Coleman, federal funds consultant, appeared before the Board with a letter from the Office of Revenue Sharing setting our general revenue sharing allocations for period 13 (October 1, 1981 thru September 30, 1982) at \$467,224. Final amounts have been computed for entitlement period 12 using final data. Our government's final period 12 entitlement is \$15,847 less than the amount estimated for the entitlement period. The adjustment for period 12 has been subtracted from our estimated period 13 allocation to compute the estimated period 13 entitlement of \$451,377. Mrs. Bradley moved
