Private road

Wayne Kellum, zoning administrator, and Roy Sturtridge, representing Lynn and Ann Kindred, appeared before the Board to request the approval of an easement for a private road for purposes of obtaining approval for a building permit. Mr. Sturtridge indicates that this request for a private road easement is Lot No. 5 of the preliminary plat of Yankee Tank Subdivision (not a platted area). After discussion it was moved by Mr. Neis that this request be approved subject to the following conditions:

- (1) That a 70 foot private road easement to serve Lots 4 and 5 of the preliminary plat of Yankee Tank Subdivision be recorded in the Register of Deeds Office, and
- (2) When the public sewer or lagoon is available to serve these lots, that these individuals connect to the sewer.

Motion seconded by Mr. Cragan, and carried unanimously. Mr. Sturtridge was instructed that this private road will not be the responsibility of the township or county to maintain. It should be noted that this private road will serve as an ingress and egress for two residences.
