At the hour of 10:00 a.m., the Board discussed a planning item with Linda Finger, staff member of the Lawrence-Douglas County Planning Department. Also in attendance was Wayne Kellum, zoning administrator. The Board considered Item No. 6 from the Lawrence-Douglas County Planning Commission minutes of December 16, 1981, which item is a Final Plat of Clinton Corner Subdivision, a small subdivision in the County, containing approximately 6.03 acres. The property is located on the northwest corner of the intersection of U. S. Highway 40 and Kanwaka Township Road No. 83 approximately 2½ miles west of Lawrence, submitted by D. Don Haines for William and Betty Brink. This item comes to the Board with a recommendation of unanimous approval from the Planning Commission with a recommendation for the acceptance of easements and road rights-of-way, subject to the following condition:

- (1) The plat's approval be made contingent to the approval and publication of the pending rezoning request to B-1 for this property.

After discussion it was moved by Mr. Neis that the Board concur in the recommendation of the Planning Commission, subject to the above described condition seconded by Mr. Cragan, and carried unanimously.
