The Board of County Commissioners of Douglas County met in regular adjourned session with two members of the Board present. Mrs. Bradley was absent due to attending a Jayhawk Area Agency on Aging meeting in Topeka. Student representative Beth Cooley was also present for the meeting.

Approved the minutes of the meeting of February 24, 1982.

Kathy Hamilton, Valleyview Administrator, notified the Board that Lavern C. Glover terminated February 25, 1982.

Mrs. Hamilton then recommended that Patricia A. Gallagher in the position of Office Assistant be reclassified to Social Work Designate, effective February 13, 1982, and also that Rebecca R. Thornton in the position of Nurse Aide at the rate of \$3.61 per hour, be reclassified to the position of Certified Nurse Aide at the rate of \$3.81 per hour, effective February 13, 1982. After discussion it was moved by Mr. Cragan that these recommendations be approved, seconded by Mr. Neis, and carried.

Mrs. Hamilton then presented the Board two quotes for the purchase of a typewriter. Mrs. Hamilton recommended that the Board accept the low quote of International Business Machines Corporation, Topeka, for an IBM "Selectric" III Typewriter, Model 6705, Correcting Dual Pitch, 15.5" paper capacity, in the amount of \$879.75. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

Mrs. Hamilton then presented the Board two quotes for the purchase of a wheelchair. Mrs. Hamilton recommended that the Board accept the low quote of Roney Plaza Drug, Lawrence, for a standard size wheelchair, with detachable leg rests, in the amount of \$166. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

Jerry Kemberling, noxious weed director, appeared before the Board with two quotes for the purchase of a roll bar for an International 706 Tractor. Mr. Kemberling recommended that the Board accept the low quote of Zimmerman Steel Company, Inc., Lawrence, for the roll bar, in the amount of \$239. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of February 25, 1982.

The Board approved Commissioners Cancellation Order No. 3043 and 3044. Orders are on file in the office of the County Clerk.

The Board noted receipt of application for cereal malt beverage license from Michael Moddrell for use at Floyd's Bait and Tackle, Route 5, Lawrence, Kansas. The application was signed and remitted to the Wakarusa Township Board.

The Board met with representatives of the six Douglas County banks to discuss the rotation of the county's checking account. After discussion it was agreed that the rotation of the active funds would continue in the order as established by a drawing six years ago. The Board then discussed the problem of transportation to the two out-of-town banks, in Eudora and Baldwin. The bankers told the Board an alternative solution might be to keep the active funds in Lawrence banks with an equitable amount deposited in savings accounts with the Eudora and Baldwin banks. That money could be transferred by wire. Lynn Anderson, president of First National Bank and spokesman for the group, said the bank officers would meet again to try and determine a fair system of deposits.

No further business, the Board adjourned to meet on Wednesday, March 3, 1982.
