Phil Leonard, emergency preparedness/risk management coordinator, explained health insurance to the elected officials and department heads. Mr. Leonard stated that he had contacted 33 companies and only three responded with proposals. Mr. Leonard recommended that the Board approve the proposal from Blue Cross-Blue Shield concerning the rates that will be charged for the contract year June 1, 1982 thru May 31, 1983 for the coverages listed below:

Blue Cross:	80/20 co-deductible.
Blue Shield:	80/20 co-deductible.
	Full X-ray rider to cover all charges.
	Full laboratory rider to cover all charges.
Major Medical:	\$100 deductible.
Lifetime Maximum:	\$1,000,000

The rates for the above coverage will be as follows:

Single Coverage:	\$63.91 per month per employee covered. (This amount is paid by Douglas County).
Family Coverage:	\$177.63 per month per family covered. (The total cost to the employee for family coverage will be \$177.63 minus \$63.91 for a total cost of \$52.48 per pay period).

After discussion it was moved by Mr. Neis that these Blue Cross-Blue Shield rates be approved and request Mr. Leonard to contact Blue Cross-Blue Shield to notify them that we wish to accept the coverages on the appropriate date and continue our program with them, seconded by Mr. Cragan, and carried unanimously.
