M/B terminal

George Little, data processing director, appeared before the Board and presented the Board a Notice to Bidders for the purchase or lease of one local mode terminal control unit and recommended that we publish this notice on June 25, 1982, and that we receive sealed bids until 10:00 a.m., C.D.T., on Monday, July 26, 1982, at which time those bids will be publicly opened in the Office of the Douglas County Board of Commissioners. After discussion it was moved by Mr. Cragan that this Notice to Bidders be so published with the bids to be received until 10:00 a.m., C.D.T., on Monday, July 26, 1982, seconded by Mr. Neis, and carried unanimously.

new courtroom

The Board had asked three architectural firms to submit proposals for construction and budgeting services for a new district courtroom located on the lower level of the Douglas County Judicial and Law Enforcement Center. After reviewing the three proposals it was moved by Mr. Cragan that the Board accept the lowest proposal which was submitted by Walt Hicks, representing Walter J. Hicks and Associates, Lawrence, as follows: \$35 per hour to prepare budget figures (a minimum of 16 hours and a maximum of 32 hours) and 8% of the total cost of the construction project. Motion seconded by Mr. Neis and carried unanimously.

Purch mower

At the hour of 10:00 a.m., as advertised, the Board opened bids for the purchase of a long reach side arm mower for the public works department. Two bids were received. After review it was moved by Mr. Neis that we take the bids under advisement for review by Mr. Dooley and to make a recommendation at a later time, seconded by Mr. Cragan, and carried unanimously.

Aileen Hadl, clerk in the budget office, appeared before the Board with a quote from M & M Office Supply, Lawrence, for the purchase of three #239 secretarial chairs, All-Steel, #260 bronze, Wollaby, regular carpet casters in the amount of \$185 each for a total of \$555. Mrs. Hadl recommended that this quote be approved as M & M Office Supply is the only local supplier who can furnish these chairs to be compatible with the other office chairs in the budget department. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.
