Ruth Foster, Valleyview administrator, appeared before the Board to recommend employment of the following:

(3) Sallie J. Falk, in the position of housekeeping assistant, permanent, full-time, at the rate of \$3.50 per hour, effective August 12, 1982.

Mrs. Foster then notified the Board that Sandra Parker will terminate on August 13, 1982.

Mrs. Foster then recommended that Desmond Chikezie be reclassified from laundry aide, temporary, part-time, at the rate of \$3.35 per hour to certified nurse aide, permanent, full-time, at the rate of \$3.55 per hour, effective July 31, 1982. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mrs. Bradley, and carried.

Ted McFarlane, Douglas County ambulance service manager, appeared before the Board with the following recommendations:

(1) Change the status of Mark Atkinson from permanent, full-time, to an indefinite leave-of-absence, effective August 9, 1982. The indefinite leave will not allow him to accrue any benefits of employment, but will allow the county, at its option, to reinstate him to full-time status within one year.

(2) Change the status of James O. Burns effective August 2, 1982. Mr. Burns has been filling in for vacation leave this summer and Mr. McFarlane would like to keep Mr. Burns on the employee list in an inactive status, with no accrual of benefits, to allow the ambulance department to utilize Mr. Burns in the future during manpower shortage times.

After discussion it was moved by Mr. Cragan that these recommendations be approved, seconded by Mrs. Bradley, and carried.

Mr. McFarlane then presented the Board Notice to Contractors for the complete construction of the new Douglas County Ambulance Service Building, 225 Maine Street, Lawrence. Mr. McFarlane recommends that this Notice to Contractors be published on August 11, 18 and 25, 1982, in the newspaper of record of Douglas County and recommends that sealed bids be received at the office of the Board of County Commissioners of Douglas County until 10:00 a.m., C.D.S.T., on Thursday, September 9, 1982, at which time the bids will be publicly opened. After discussion it was moved by Mr. Cragan that the recommended dates for publication and bid opening be accepted, and also that the paragraph of the minutes of July 28, 1982, concerning the Douglas County Ambulance Service Building at 225 Maine be rescinded, seconded by Mrs. Bradley, and carried.
