The next item for consideration by the Board was Item No. 13 from the Lawrence-Douglas County Planning Commission minutes of July 28, 1982. This item is a Final Plat of Parkway Center, generally described as being at the south-east corner of Clinton Parkway and Dragstrip Road, containing approximately 7.48 acres, submitted by John Selk for Dorothy F. Booth. This item comes to the Board with a recommendation of approval from the Planning Commission, subject to the following conditions:

- (1) That the lots be pinned by a licensed engineer or a performance bond be placed with the Planning Office to guarantee the lots be pinned; and,
- (2) That the restricted access along Clinton Parkway and Dragstrip Road be shown on the plat and the rights-of-way for Dragstrip Road be increased to 40 feet.

After discussion it was moved by Mr. Neis that the Board acknowledge receipt of the plat accepting the rights-of-way and easements and also that the Board concur in the recommendation of the Planning Commission, subject to the above described conditions, seconded by Mrs. Bradley, and carried.
