Lechwood Co., Inc. Recorder No. 185428-12-78

- (1) Equipment, 3 five-ton roof units set on the ground on the west side of the building.
- (2) Insulated duct run above ceiling with 9 supplies and 3 returns.
- (3) Furnish gas hook-up, material, and labor.
- (4) Extended 5-year warranty on compressor and extended 10-year warranty on heat exchangers.
- (5) Furnish three lock covers for thermostats.

Four quotes were opened on June 14, 1982, for this purchase and installation and the low quote of Cloud Trane Air Conditioning Company was accepted at that time but was delayed due to funding. After discussion it was moved by Mr. Cragan that the amount of \$6140.10 be funded from Capital Improvement line item of the 1982 Fair Budget and the remaining \$5534.90 be funded from the 1982 Revenue Sharing Budget, seconded by Mr. Neis, and carried unanimously. The amount of \$5534.90 was received for the sale of the Hougland house, formerly located at 1920 Harper, Lawrence, which amount was deposited in the 1982 Revenue Sharing account.

Ambulance:

Purch med equip

Brian Lawrence, assistant director of the Douglas County Ambulance Service, appeared before the Board with five quotes for the purchase of medical equipment. Mr. Lawrence recommended that the Board accept the low quote from Armstrong Industries, Northbrook, Illinois, in the amount of \$671 for the following:

After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Ambulance:

Open bids for new bldg.

At the hour of 10:00 a.m., as advertised, the Board opened bids for the complete construction of the new Douglas County Ambulance Service Building, 225 Maine, Lawrence, Kansas. Six bids were received. After a brief review it was moved by Mr. Neis that we take the bids under advisement for review by Mr. McFarlane, Douglas County Ambulance Service Manager, and Walter J. Hicks and Jeff Messick, representing Walter J. Hicks & Associates, architects, Lawrence, and to make a recommendation at a later time, seconded by Mr. Cragan, and carried unanimously.

Pub. Works:

Purch aggregate

Mike Dooley, public works director, appeared before the Board with two quotes for the purchase of 3500 tons of AB-3 Aggregate for use on Douglas County Route No. 442 west of Stull. Mr. Dooley recommended that the Board accept the low quote from Killough, Inc., Ottawa, Kansas, in the amount of \$3 per ton for a total amount of \$10,500. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously.

Pub. Works:

Map showing culvert replacement

Mr. Dooley then presented the Board a map showing the location and priority numbers for scheduling replacement of Douglas County culverts. Mr. Dooley recommended that the Board accept the map and priority schedule as a work plan for his department to design replacement structures and schedule replacement with county funds and forces. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously. The map is on file in the public works department.

12 mo. Accomplishment Report

Mr. Dooley then presented the Board a Department of Public Works Accomplishment Report for a twelve month period beginning July 1, 1981.

Map showing bridge replacement

Mr. Dooley then presented the Board a map indicating thirteen structures which he believes to be priority off-system bridges for replacement and rehabilitation. Mr. Dooley also presented a table which delineates age, weight limit, estimated remaining life, and a recommendation for replacement of these structures. Mr. Dooley recommended that these specified bridges be designed and replaced using a combination of county funds and forces, county special bridge funds to finance design and replacement, and federal aid bridge replacement off-system (BRO). The map and the table specifically indicate what combination of funds and replacement method is recommended for each structure. After discussion it was moved by Mr. Cragan that these recommendations be approved, seconded by Mr. Neis, and carried unanimously. The map is on file in the public works department.

Pub. Works:

R/W Miller 3-13-80

Mr. Dooley then presented the Board an Easement for Road Right-of-Way from Wilma Miller, a single woman, for a drainage structure for the following described lands, situated in Douglas County and State of Kansas, to-wit:

Commencing at the Northeast corner of the Southwest Quarter (S.W.1) of Section 3, Township 13 South, Range 20 East of the Sixth Principal Meridian in Douglas County, Kansas, thence South on the East line of said Southwest Quarter (S.W.1) on an assumed bearing of S. 00°00'00" E. a distance of 608.00 feet for a point of beginning, thence S. 90°00'00" W. a distance of 25.00 feet; thence S. 0°00'00" E. a distance of 100.00 feet; thence S. 90°00'00" E. a distance of 25.00 feet to a point on the East line of said Southwest Quarter (S.W.1), thence N. 0°00'00" W. on the East line of said Southwest Quarter (S.W.1) a distance of 100.00 feet to the point of beginning.
