At the hour of 9:00 a.m., as advertised, Mike Dooley, public works director, appeared before the Board in regard to a Request to Vacate Roads. This request is to vacate part of Road No. 516, part of Road No. 34, and Road No. 318. Mr. Dooley stated that he had not received concurrence from the Eudora Township Board. After discussion it was moved by Mr. Neis that the Board defer action until we have received concurrence from the Eudora Township Board, seconded by Mr. Cragan, and carried unanimously.

Mr. Dooley then presented the Board three quotes for the purchase of regular gasoline, diesel fuel, and unleaded gasoline. Mr. Dooley recommended that the Board accept the low quote from Zaroco, Inc., Lawrence, for the purchase of the following: approximately 2000 gallons of regular gasoline at the total price of \$1.043 per gallon, approximately 4000 gallons of diesel fuel at the total price of \$0.989 per gallon, and approximately 2500 gallons of unleaded gasoline at the total price of \$1.077 per gallon. After discussion it was moved by Mr. Neis that these recommendations be approved, seconded by Mr. Cragan, and carried unanimously.
