The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of October 20, 1982.

The Board considered the appointment of Ermal Whaley, Route 2, Lawrence, as a member of the Douglas County Council on Aging Board of Directors to fill the unexpired term of Maxine Mott, which term expires on September 30, 1984. After discussion it was moved by Mr. Cragan that this appointment be approved seconded by Mr. Neis, and carried unanimously.

At 10:00 a.m., as advertised, the Board opened bids for the purchase of port-able video recording equipment and accessories for use by the Douglas County Ambulance Service in their training program. Three bids were received. Af-ter a brief review it was moved by Mr. Neis that we take the bids under ad-visement for review by Mr. McFarlane and to make a recommendation at a later time seconded by Mr. Gragen and carried unanimously ambulance: Open Dids video time, seconded by Mr. Cragan, and carried unanimously.

Mr. McFarlane then recommended to the Board the purchase of a 1983 ambulance from Mr. Jay Tucker, Modular Vehicles, Inc., Colorado Springs, Colorado, at a price of \$28,537, FOB, Orlando, Florida. Mr. Tucker is the regional repre-sentative of Wheeled Coach Corporation of Orlando, Florida. Wheeled Coach is the original manufacturer for the ambulance vehicle ordered on June 21, 1982, from the Dietz Company, Wichita, Kansas. This order was cancelled in action taken on October 7, 1982. Modular Vehicles, Inc., has agreed to pro-vide the vehicle as originally specified at substantially the same price. After discussion it was moved by Mr. Cragan that this recommendation be ap-proved, seconded by Mr. Neis, and carried unanimously.
