Mike Dooley, public works director, appeared before the Board with a Request for Construction Project Off-System Roads Program, for Bridge No. 12.00N-23.78E, whereas the State Highway Commission of Kansas, has been designated as Agent for Douglas County. The State Highway Commission is hereby requested to program for construction that portion of road described as follows: Beginning 0.3 miles west of Johnson County on east-west road between Section 15 & 22, Township 13S, Range 21E, thence east 0.3 miles to include grading, culverts and bridges, in the estimated total amount of \$140,000. Douglas County states that sufficient funds are now, or will be available and are hereby pledged to the State Highway Commission in the amount and at the time required for the Supplementing of Federal funds available for the completion of this project. After discussion it was moved by Mr. Neis that this Request for Construction Project be approved, seconded by Mr. Cragan, and carried unanimously.

Mr. Dooley then presented correspondence from Mr. Lynn Burris, Jr., State Liaison Officer of The Kansas State Park and Resources Authority, which requests an Annual Operation and Maintenance Assurance Statement on Wells Overlook Regional Park. This Assurance Statement is required of Douglas County since this project was in part funded by the Bureau of Outdoor Recreation funds. The statement includes a number of requirements for maintenance and appearance of the facility and a certification of non-discrimination in the use of the facility. After discussion it was moved by Mr. Neis that this Assurance Statement be executed and returned to the state for signing by the State Park and Resources Authority, seconded by Mr. Cragan, and carried unanimously.
