The Board noted receipt of application for cereal malt beverage license from John H. Senn for use at Smiley Pams, Highways 24-40 & 32, Lawrence, Kansas. The application was signed and remitted to the Grant Township Board.

Workers' Comp.

Phil Leonard, emergency preparedness/risk management coordinator and Jack Landreth, Charlton Manley Inc., appeared before the Board with a recommendation that the County allow the Douglas County Health Department to join the County on the Workers' Compensation Policy. Payment would be made by the County with the Health Department reimbursing the County for the Health Department's share of the premiums. By combining the two policies it would save the Health Department money. After discussion it was moved by Mrs. Hiebert that the Health Department be allowed to join the County's Workers' Compensation Policy, seconded by Mrs. Bradley, and carried unanimously.

Purch fuel

Mike Dooley, public works director, appeared before the Board with four quotes for the purchase of regular gasoline, unleaded gasoline and diesel fuel. Mr. Dooley recommended that the Board accept the low quote of Zarco, Inc., Lawrence, in the amount of \$0.9150 per gallon for 1300 gallons of regular gasoline, \$0.9450 per gallon for 4650 gallons of unleaded gasoline and \$0.8380 per gallon for 2000 gallons of diesel fuel. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

At 10:00 a.m., Wayne Kellum, zoning administrator; Dan Young, county counselor; Mike Dooley, public works director; Price Banks, Lawrence-Douglas County Planning Department director; David Guntert, Lawrence-Douglas County Planning Department staff member; and Mr. & Mrs. G. W. Hoffman appeared before the Board to again discuss the Hoffman's request for a building permit on a tract of land located in Wakarusa Township, approximately one-half mile east of Highway 59, on County Road No. 458. After a lengthy discussion it was moved by Mrs. Bradley to allow the Hoffman's request for a building permit with the following condition:

- (1) A 90 feet set-back to allow a road to be built to County specifications in the event that it would ever need to be turned over to the township,

seconded by Mrs. Hiebert, and carried unanimously. This will be the third house on this private road.
