The Board approved Commissioners Cancellation Order No. 3152. Order is on file in the office of the County Clerk.

Pub. Works: Open bids bridge plank
Mike Dooley, public works director, appeared before the Board and opened two quotes for bridge plank with one of the quotes being a no bid. After discussion it was moved by Mrs. Bradley that the Board take these quotes under advisement with Mr. Dooley to make a recommendation at a later time, seconded by Mrs. Hiebert, and carried unanimously.

Open bids steel
Mr. Dooley then opened three quotes for the purchase of structural and piling steel. After discussion it was moved by Mrs. Bradley that the Board take these quotes under advisement with Mr. Dooley to make a recommendation at a later time, seconded by Mrs. Hiebert, and carried unanimously.

Pub. Works: Procedure Form FAS 511
Mr. Dooley then presented an Authority and Method Procedure Form covering Project No. 23 C-1492-01 (RS 196 [2]) which consists of 0.227 miles of grading and bridge work on FAS Route 211, 0.9 miles south Lawrence. County funds in the approximate amount of \$152,900 will be available for the matching of federal funds to finance construction work on this project. Mr. Dooley then presented a Certification of Real Property Acquisition Procedures for the same project. This certifies that all real property acquired for the project was done so in compliance with listed procedures which are required by Federal and State law. After discussion it was moved by Mrs. Hiebert that these documents be approved, seconded by Mrs. Bradley, and carried unanimously.

Ambulance: Accept new station
After reviewing the requirements of the Davis-Bacon Act with Ernest Coleman, federal funds consultant, the Board officially accepted the new Douglas County Ambulance Station at 225 Maine, Lawrence.

Weed Dept: Purch chem.
Jerry Kemberling, noxious weed director, recommended the purchase of 5 gal. Banvel from Mid States Ag Chemical, Eudora, in the amount of \$218.69. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

No further business, the Board adjourned to meet on Thursday, May 19, 1983. On Wednesday, May 18, two commissioners will be out of town so no meeting is scheduled.
