At the hour of 10:00 a.m., the Board discussed two planning items with David Guntert, staff member of the Lawrence-Douglas County Planning Department, and Wayne Kellum, zoning administrator. The Board considered Item No. 15 from the Lawrence-Douglas County Planning Commission minutes of April 27, 1983. This item is CUP-3-2-83 which is a Conditional Use Permitted upon review request for the operation of a sales, service and repair business for chain saws, brush cutters and miscellaneous accessory equipment and parts in an A (Agricultural) district. The property is generally described as being located one-half mile south of the Knights of Columbus (E. 23rd/Highway 10) on the O'Connell Youth Ranch Road and submitted by Cecil M. Leonard. This item comes to the Board with a recommendation for denial from the planning commission. After discussion it was moved by Mrs. Bradley that the Board deny the request based upon the recommendation of the planning commission, seconded by Mrs. Hiebert, and carried unanimously.

This item is to consider a text amendment to allow signs in the B-3 (Limited Commercial) district, initiated at the request of the Douglas County Zoning Administrator. The Board met with members of the Douglas County Extension Council, represented by Ralph Leonard, chairman, and with Dr. Bob Newsome, who is representing the Director of Extension at Kansas State University, to discuss the budget for the Extension Council for the period January 1, 1984 to December 31, 1984. After a complete review of the budget as it was presented, which totaled \$256,200 and which included an appropriation of the Douglas County tax funds of \$191,095 and reflects approximately a 6 1/2% increase, it was moved by Mrs. Bradley that the budget be adopted and that the county budget appropriations be so set. Motion seconded by Mrs. Hiebert and carried unanimously by all five members of the group voting in accordance with the terms of K.S.A. 2-610 as amended.
