However, if those employees fail to sign up for the group primary payer plan, the federal government increases the cost of Medicare coverage. This penalty could prove costly. Surcharge on  
landfill

The Board authorized Mike Dooley, public works director, to request of N. R. Hamm Quarry, Inc., Perry, Kansas, a surcharge be placed on the landfill in the following amounts: \$0.08 to be applied to every minimum charge and a surcharge of \$0.15 per ton to every tonnage charge. This request is being made in accordance with Paragraph 5 (Operation Costs and Financing) of the Agreement dated November 10, 1980, between N. R. Hamm, Douglas County, and the City of Lawrence. Money for this surcharge will be used for access road maintenance and repair. It was moved by Mrs. Hiebert that this option be exercised in the Agreement effective August 1, 1983, seconded by Mr. Neis, and carried.
