Based upon recommendation of Dan Young, county counselor, and after discussion it was moved by Mrs. Bradley that the Douglas County ambulance service not proceed with the petition for review in the Supreme Court on the wage and hour litigation, seconded by Mrs. Hiebert, and carried unanimously.

The Board discussed a Site Plan Review (SP-8-37-83) with David Guntert, Lawrence-Douglas County Planning Department staff member. Wayne Kellum, zoning administrator, was also present. This site plan is for a used car sales lot to be located on the north side of Highway 56 east of Worden, submitted by Kenneth Pettibon. The planning staff recommended approval of this site plan subject to the following conditions:

(1) The recommendations of the Kansas Department of Transportation for entry improvements be added to the site plan; and,

(2) Any advertising sign meet the requirements for the B-2 district.

After discussion it was moved by Mrs. Hiebert that the Board concur in the recommendations of the Planning Department subject to conditions (1) and (2) as described above, seconded by Mrs. Bradley, and carried unanimously.

The Board opened three quotes for the purchase of regular gasoline, unleaded gasoline, and diesel fuel.
