Tom McGee, assistant public works director, appeared before the Board and presented two contracts for right-of-way for Project No. 09.69N-11.00E, Road No. 240 (Rd. I.D. No. 1100E), between the Board of Commissioners of Douglas County and the following:

(1) Donald Anthony Stiteler and Lillie May Stiteler, husband and wife, for 0.195 acres of right-of-way easement and 25 rods of barb fence, in the lump sum of \$374.10.

(2) Gerald Dwyer and Sharon L. Dwyer, husband and wife, for 0.034 acres of right-of-way easement, in the lump sum of \$34. This lump sum payment includes allowance for 0.02 acres of soybean crop.

After review of these contracts it was moved by Mrs. Hiebert that they be approved, seconded by Mr. Neis, and carried unanimously.

Mr. McGee then stated that Project No. 30C-1044-01 (Douglas County-Franklin County line bridge) has been inspected by the Douglas County Public Works Department and found to be satisfactory for final acceptance. Mr. McGee then presented the Board D.O.T. Form 226 "Change in Plans and Construction No. 3F" for Project No. 23 C 1635-01/RS 1084[4] for grading and bituminous surfacing. This change in plans is for special provision (sanitary sewer) which is being added to the contract so that ABS pipe may be used as requested by the contractor with no net increase or decrease. After discussion it was moved by Mr. Neis that this change in plans and construction be approved, seconded by Mrs. Hiebert, and carried unanimously.

Mr. McGee then presented the Board D.O.T. Form 226 "Change in Plans and Construction No. 2T" for Project No. 23 C 0330-01/AHL-PMS 1593[2] Phase III for grading and bituminous surfacing. This is for 600 cu. yds. common excavation for a total net increase of \$4500. After discussion it was moved by Mrs. Hiebert that this change in plans and construction be approved, seconded by
