Ambulance:  
Purch lanterns

Ruth Foster, Valleyview administrator, notified the Board of the following terminations: Ann Hensley on July 27; Evelyn Richardson, Debra Riley, and Tina Hilliard on July 28; Patricia Sedgwick and Karen Laushman on August 1; Dorothy Tubbs on August 6; and Ellen Kampfe on August 10.

Mrs. Foster then recommended employment of the following:

- (1) Penny K. Kampfer, in the position of nurse aide, temporary, part-time, at the rate of \$3.35 per hour, effective July 28, 1984.
  - (2) Cynthia D. Roubison, in the position of certified nurse aide, temporary, part-time, at the rate of \$3.55 per hour, effective August 3, 1984.
  - (3) Clarence H. Tremble, in the position of certified nurse aide, temporary, part-time, at the rate of \$3.55 per hour, effective August 5, 1984.
- After discussion it was moved by Mr. Neis that these recommendations be approved, seconded by Mrs. Bradley, and carried.

Mrs. Foster then recommended the following changes, effective July 28, 1984: Casandra Shain from graduate practical nurse, at \$5 per hour, to licensed practical nurse at \$5.50 per hour; Grisell Lopez-Hernandez from certified medication aide at \$3.90 per hour, to orientation aide at \$4 per hour; and Theresa Cook from certified medication aide at \$3.65 per hour, to relief certified medication aide at \$3.75 per hour. After discussion it was moved by Mr. Neis that these recommendations be approved, seconded by Mrs. Bradley, and carried.

Ted McFarlane, Douglas County Ambulance Service Director, notified the Board that Mark Atkinson and James Burns terminated August 9, 1984.

Mr. McFarlane then requested a pay adjustment for Susan Todd from \$12,895 per year to \$13,362 per year. The original amount was approved in error on July 18, 1984, as the 1983 pay scale was used. After discussion it was moved by Mr. Neis that this request be approved seconded by Mrs. Bradley, and carried.

Mr. McFarlane then presented the Board two quotes for the purchase of lanterns and battery chargers. Mr. McFarlane recommended that the Board accept the low quote from Bernie Electric Wholesale Co., Inc., Kansas City, Kansas, for the purchase of six Teledyne hand lanterns and 2 battery chargers at \$72 each and \$32.40 each, respectively for a total price of \$496.80 plus shipping. After discussion it was moved by Mr. Neis that these recommendations be approved, seconded by Mrs. Bradley, and carried.

Mr. McFarlane then presented the Board Douglas County Ambulance Service Financial Highlites as of June 30, 1984.

No further business, the Board adjourned to meet on Friday, August 10, 1984, at 9:00 a.m., for the sole purpose of canvassing ballots. The next regular meeting will be on Monday, August 13, 1984.
