

One O'clock P.M. November 21 1864

Board of Commissioners met pursuant to adjournment  
Henry Webber Trustee of Marion Township, <sup>being</sup> present the  
Board took up the account of Douglas County with said  
Township and there being a discrepancy in the account as  
kept by the Co. Treasurer and said Trustee. It was our motion  
ordered that the sum of Four hundred and eighty seven dollars  
and forty six cents (\$487.46) be taken and considered as the amount  
due said Township prior to the Tax of 1863. and said settlement  
was agreed to by the Trustee.

The Treasurers report was again  
taken up and our motion accepted and adopted.

Certificate  
of sale Number 310 of the sale of Lands of 1861 was presented  
with certificate of Treasurer that said sale was illegal - Ordered  
that \$10.79 be refunded to F. Gleason holder of said certificate being  
the amount of Certificate with interest. Also certificate of  
sale No 430 of sale of 1862 with certificate that the sale was  
illegal. Ordered \$2.64 be refunded to F. Gleason holder of said  
certificate being the amount of certificate with interest.
