

A petition was presented signed by Wesley Garrett and a legal number of petitioners asking that a road be reestablished at certain points named therein, with proof of legal publication and notice whereupon it was ordered that Thomas Oliver John Bishop and George Parker be appointed to meet with the County Surveyor at the house of Wesley Garrett on the 12th day of November 1867 to view the route of said proposed road as required by law.

A petition was presented signed by Charles H. Ingalls and others asking that a road be reestablished at certain points named with proof of legal publication whereupon it was ordered that William P. Ramsey Samuel Hindman and Thomas Hall be appointed viewers of said proposed road to meet with the County Surveyor on the 24th day of October 1867 at the house of Samuel Harbot.

A petition was presented signed by Joseph L. Jones and a legal number of petitioners asking that a road be established at certain points named therein with proof of legal publication. On motion it was ordered that M. S. Winters J. A. Kelley and Oliver Parker be appointed to view the route of said proposed road to meet for that purpose on the 5th day of November 1867 at ten o'clock a.m. at the house of J. L. Jones.

A petition was presented signed by M. S. Winters and others asking that a road be located at certain points named therein and on motion it was laid over until the next meeting of the Board.

The petition of Bethuel Hetchcock and others for review of Road was laid over.
