

had been made on motion it was ordered that H. White John L. Moss and F. McDerby be appointed viewers of the proposed change of road and Holland Whelan Surveyor and it was further ordered that said viewers and surveyor meet at the house of L. Mc Sawyer on the 19th day of February AD 1867 at ten o'clock a.m. and thence proceed to view locate and survey the route of the change of road as petitioned for.

A petition was presented signed by H. W. Cole and others asking that a change be made in the Popuka and Ottawa road as follows. Begin where said road crosses the North line of the S.W. 1/4 of Section 1 Town 14 Range 17, thence East on said line to the Township line thence South to where said road crosses the East line of the N.E. 1/4 of Section 12 Town 14 Range 17. And the Board being satisfied that legal notice and publication had been made, it was on motion ordered that Harry White John L. Moss and F. McDerby be appointed viewers and Holland Whelan Surveyor and that said viewers and surveyor meet at the house of L. Mc Sawyer on the 19th day of February 1870 and thence proceed to view locate and survey the route of the proposed change as petitioned for.

A petition was presented signed by J. H. Bane and a legal number of petitioners asking that a road be established at the following points to wit: Beginning at a point 40 rods South of the S.W. corner of the S.E. 1/4 of Sec. 4 Township 14 Range 20 running East one half mile, thence South on the Section line to Finland Station on the Brasenworth Lawrence and Galveston Railroad. The Board being satisfied that legal notice and publication had been made on motion it was ordered that C. H. Nancy John Hill and S. Ogden be appointed viewers of the proposed road and Holland Whelan Surveyor and that said viewers and surveyor meet on the 29th day of January AD 1869 at the house of H. W. Williams and thence proceed to view locate and survey the route of said proposed road as required by law.

A petition was presented and read signed by F. L. Robinson and others asking that a road be established at the following points to wit: Begin at the S.W. corner of the S.E. 1/4 of Sec. 22 Township 14 Range 20 thence East on Section line until it intersects the Ballwin City and Eudora road and the Board being satisfied that legal notice and publication had been made it was ordered that Hugh Williams R. A. Pier and J. T. Stuntz be appointed viewers and Holland Whelan Surveyor and that said viewers and surveyor meet on the 16th day of February 1869 at the house of F. L. Robinson and thence proceed to view locate and survey said proposed road as required by law.

A petition was presented and read signed by H. W. Thompson and others asking that a road be established on the following route to wit: Begin at the S.E. corner of the N.W. 1/4 of Section 39 Town 13 Range 19, thence West 220 or 240 rods as may seem best thence North West to the bluffs thence nearly West to the West line of the Township thence to the road running from Lawrence to Emporia. And the Board being satisfied that legal notice and publication had been made and H. W. Thompson one of the petitioners having filed his bond with approved security conditioned for the payment of all costs accruing on
