

In the matter of the petition
of William B. Barker and
others for a County road

The petitioners having made application for
the establishment of a road as follows

Beginning at the house of S. B. Hill thence by the most practicable ^{out} to the
South East corner of the North East quarter of Section 13 Town 13 Range 18
thence East one half mile to the middle of Section 18, thence South one half
mile, thence East as near as practicable to the South East corner of Section 15
Town 13 range 19, thence South one mile to the South East corner of Section 23 thence South
one half mile And William B. Barker one of the petitioners having filed his
bond in the sum of One hundred and fifty Dollars payable to the State
of Kansas, for the use of the County of Douglas. Conditioned for the pay-
ment of all costs and expenses accruing upon said application, in
case the prayer of the petitioners be not granted, and it appearing that
said petition is signed by at least twelve(12) householders of Douglas Coun-
ty, and that notice of the presentation of the petition has been given ac-
cording to law It is Ordered that S. O. Thacker, J. C. Vincent and W. H. S.
Hawfield be and they hereby are appointed receivers and Holland Wheeler
Surveyor of said road and that said receivers and Surveyor meet at
the house of Wm. B. Barker on the day of 1869 and after
being duly sworn proceed to the discharge of the duties of their several
appointments as required by law. It is further ordered that the County
Clerk issue in the name of the Board the necessary orders to said receivers
and Surveyor.

In the matter of the petition
of W. A. Simpson and others
for a County road

The petitioners having made application
for the establishment of a road as follows

Beginning at a point adjoining the City of Lawrence on the South where
the land of J. M. Brady and S. N. Simpson comes thence due South to the Section
line between Sections 6 and 7, thence West to the South East corner of Section 1
thence East and South to the South East corner of Section 18 all in Township 13
Range 20 And W. A. Simpson one of the petitioners having filed his bond
in the sum of One Hundred Dollars payable to the State of Kansas for
the use of the County of Douglas conditioned for the payment of all costs
and expenses accruing on said application in case the prayer of the petition-
ers be not granted which bond is hereby accepted and approved. And it ap-
pearing that said petition is signed by at least 12 householders of Douglas
County, and that notice of the presentation has been given according
to law It is Ordered that D. C. Haskell, Turney Sampson and A. G. Brooks
be and they hereby are appointed receivers and Holland Wheeler Surveyor
of said road and that said receivers and Surveyor meet at the house of W. A.
Simpson on the day of 1869 and after being duly sworn proceed to
the discharge of the duties of their several appointments according to law
It is further ordered that the County Clerk issue in the name of the Board
the necessary orders to the said receivers and Surveyor, and that said
receivers report their proceedings in the premises at the next session of
the Board
