Cawthill, Johnson Smith and Levi Woodward he and they hereby are appointed viewers and Holland Wheeler Surveyor of said road and that said viewers and surveyor meet on the 4th day May 1870 at the place of beginning designated in the petition and after being duly sworn proceed to the discharge of the duties of their several appointments according to law it is further ordered that the County Clerk issue in the name of the board the necessary order to said viewers and surveyor.

The petitioners having made application for the establishment of a road as follows beginning at a point thirty three rods out of the South East corner of Section Thirty two (32) town twelve (12) range nineteen (19) thence northerly about eight (8) rods, to a point sixteen (16) rods West of the South West corner of the North half of the South West quarter of Section Thirty three (33) town twelve (12) range nineteen (19) thence East on the line between the North and South half of the South West quarter of said section Thirty three (33). to intersect a North and South road. Also that a portion of the road located on the section line between Sections Thirty two (32) and Thirty three (33) town twelve (12) range nineteen (19) be vacated as follows beginning at the North East corner of the North West quarter of Section four (4) town thirteen (13) range nineteen (19) thence vacate West one hundred and ninety three rods. And Henry Evans one of the petitioners having filed his bond in the sum of two hundred dollars payable to the state of Kansas for the use of the County of Douglas. conditioned for the payment of all costs and expenses accruing upon said application in case the prayer of the petitioners be not granted. which bond is accepted and approved and it appearing that said petition is signed by at least twelve householders of the County of Douglas. and that notice of the presentation of the petition had been given according to law it is ordered that A.E. Platt, H.L. Baldwin, N. Sturd he and they hereby are appointed viewers and Holland Wheeler Surveyor of said roads and that said viewers and surveyor meet on the 18th day of May 1870 at the place of beginning designated in said petition and after being duly sworn proceed to the discharge of the duties of their several appointments according to law it is further ordered that
