

Saturday January 7th 1871

The board of commissioners of the county of Douglas met pursuant to adjournment
there were present commissioners Groce, Jones and Hinshaw and Paul R. Brooks County Clerk,

The following proceedings were had.

William Main Trustee of Wakamia township presented an application for an appropriation
of Two hundred and fifty Dollars for the purpose of constructing a ditch running East two
miles from the Blanton road. Ordered that the sum of two hundred and fifty dollars
be and the same is hereby appropriated for the purpose of digging a ditch from Blanton road
East two miles. It is further ordered that the Clerk issue an order on the Treasurer in favor
of the Trustee of Wakamia township for the amount of said appropriation.

Ordered that the sum of One hundred Dollars be and the same is hereby appropriated to pay
Jed Groce for services rendered during the past year as chairman of the board, and that
the County Clerk issue an order on the Treasurer in favor of Jed Groce for said amount.
