

In the matter of the Subscription of Stock by Eudora Township
in the Saint Louis Lawrence and Denver Rail road

Said township of Eudora having on the 14th day of May A.D. 1870 voted on the proposition to subscribe stock to the amount of fifteen thousand dollars in the Saint Louis, Lawrence and Denver Rail road, and it appearing from the returns of said election that at least three fifths of the electors of voting at said election voted for the subscription of stock. It is ordered that the county clerk do, and he hereby is instructed to make a subscription to the Capital stock of the Saint Louis, Lawrence, and Denver Rail road Co. in the name of Eudora township to the amount of fifteen thousand dollars.

In the matter of the Subscription of Stock by the County of
Douglas in the Saint Louis, Lawrence and Denver Rail road.

Whereas the county of Douglas did on the seventh day of September A.D. 1868 subscribe for One hundred and twenty five thousand dollars of the Capital stock of the Saint Louis, Lawrence and Denver Rail road company, and whereas said company has this day asked that the terms of subscription be modified to the extent of extending the time for the completion of said road until the first day of January A.D. 1872. It is ordered that said subscription of stock be so modified, and that the time for the completion of said road through the county of Douglas be and the same is hereby extended to January 1 1872. It is further ordered that the bonds prepared and now in the hands of the county Treasurer to be used in payment of the said subscription be deposited in escrow with the second National bank of the city of Saint Louis in the State of Missouri, to be delivered to said Rail road company upon the completion of the road in full running operation from the city of Lawrence to the eastern boundary of the county. Such delivery to be made only on the order of the Chairman of the board of commissioners of this county and the President of said Rail road company and it is further ordered that whenever said bonds shall be delivered to said company the Chairman of the board shall cause coupons to be cut from said bonds to such an extent that the remaining coupons shall represent the interest that may accrue on said bonds from and after the date of said delivery.

Robert Young trustee of Leecompton township presented an application for an appropriation for the purpose of improving roads in said township.

Ordered that the sum of three hundred dollars be and the same is hereby appropriated out of the county general fund for the purpose of repairing the Leecompton and Clinton road to be expended under the direction of Robert Young trustee of said township and that the county clerk issue an order on the treasurer in favor of said trustee for said amount. It is further ordered that said trustee be and he is hereby instructed to report to this board the expenditure of said money with vouchers.

E. C. Darling Quorum of Poor Eudora Township presented an application for an appropriation for temporary support of poor in said township. It is ordered that the sum of twenty five dollars be and the same is hereby appropriated out of any moneys not otherwise appropriated for temporary support of poor in said township of Eudora and that the clerk draw an order on the treasurer for the amount in favor of said Quorum.

The bill of H. E. Turner for building bridge across Muddy creek in Grant township amounting to \$1097.57 was allowed at \$1000.

The board adjourned until tomorrow morning.
