

the South West corner of block fifty seven (57) thence East to the South East corner of block fifty (60) thence North to the S. corner of block thirty seven thence West to the South West corner of block forty (40) thence South to the place of beginning and it appearing from the affidavit of said Joseph Payer that he is the owner of a majority of the lots or subdivisions of the portion of said town site concerning which action is to be taken. It is Ordered that the board will take testimony concerning the occupancy of said town site on Thursday the 6th day of April A.D. 1871. It is further Ordered that the clerk cause notice of the time and place of taking such testimony to be advertised in the name of the board in the Weekly Astorian Home Journal and also by public notice posted on the land itself.
