

and expenses accruing upon said application in case the prayer of the petitioners be not granted which bond is accepted and approved and it appearing that said petition is signed by at least twelve house holders of the county of Douglas and that notice of the presentation of the petition has been given as required by law it is ordered that William M. New, James M. Beach and Robert Young be and they hereby are appointed viewers and T.C. Darling surveyor of said road and that said viewers and surveyor meet at the place of beginning designated in said petition and after being duly sworn proceed to the discharge of the duties of their several appointments according to law. It is further ordered that the county clerk issue in the name of the board the necessary order to said viewers and surveyor.

In the matter of the petition of Daniel Studibaker and others for the establishment of a road

The petitioners having made application for the establishment of a road as follows beginning at the South East corner of Section Thirteen (13) Town Twenty (20) Range Eighteen (18) thence North on section line, as near as practicable to the North East corner of Section Thirty Six (36) Town Thirteen (13) Range Eighteen (18) and John K. Wells one of the petitioners having filed his bond in the sum of One hundred dollars payable to the State of Kansas for the use of the county of Douglas, conditioned for the payment of all costs and expenses accruing upon said petition in case the prayer of the petitioners be not granted which bond is accepted and approved and it appearing that said petition is signed by at least twelve (12) house holders of the county of Douglas and that legal notice of the presentation of the petition has been given it is ordered that W.M. Edwin, J.M. Bowman and Horace Tucker be and they are hereby appointed viewers and S.B. Darling surveyor of said road, and that said viewers and surveyor meet at the place of beginning designated in said petition on the second day of May A.D. 1891 and after being duly sworn proceed to the discharge of the duties of their several appointments according to law. It is further ordered that the county clerk issue in the name of the board the necessary order to said viewers and surveyor.

In the matter of the petition of A. K. Martin and others for the establishment of a road

The viewers having reported in favor of the establishment of said road the report was this day publicly read, and no legal objections being made nor damages claimed, the board being of opinion that said road as laid out and surveyed will be of public utility. It is ordered that the report, plat and survey be recorded and that said road be established a public highway. It is further ordered that the county clerk issue an order in the name of the board, to the proper owners of roads, directing them to cause said road to be opened for public travel according to law.

In the matter of the petition of William P. and others for the establishment of a road.

The viewers having reported in favor of the establishment of said road the report was this day publicly read and no legal objections being made nor damages claimed the board being of opinion that said road as located and surveyed will be of public utility. It is ordered that the plat, survey and report of said viewers be recorded and that said road be established a public highway. It is further ordered that the county clerk issue an order in the name of the board directing the proper owners of roads to cause said road to be opened for public
