

is hereby appropriated out of the general county fund for the purpose of improving the Lawrence and Topeka road where it runs into and along the South line of Section 22 Town 12 Range 19 and that the county clerk issue an order on the county Treasurer payable to the Trustee of Wakarusa Township said appropriation to be expended by and under the direction of said Trustee.

In the matter of the application of the trustee of Eudora township for an appropriation to build a bridge over Captains creek in Eudora Township.

The trustee of Eudora township having made application for the appropriation of \$2000. for the purpose of building a bridge over Captains Creek. The board being of opinion that a bridge is necessary for the convenience of the general travel It is ordered that Neiland Whelan Esq be and he is hereby authorized to prepare plans and Specifications for a bridge over Captains creek in Eudora township and it is further ordered that the sum of \$1000. be and the same is hereby appropriated for the purpose of assisting in building a bridge over Captains creek on the Eudora and Olathe road and the further sum of \$1000. for making and grading approaches to said bridge and that the county clerk be and he is hereby authorized to draw an order on the county Treasurer for the amount of said appropriations in favor of the Trustee of Eudora township. Whenever said trustee shall present a certificate signed by Neiland Whelan that said bridge and approaches are completed in accordance with the plans and specifications and a certificate signed by said trustee and Chas Dorn of Eudora township that said bridge is paid for with the exception of the \$2000. hereby appropriated.

In the matter of the petition of Thomas Rayson and others for the establishment of a county road.

The petition having reported in favor of the establishment of the road. The report was read and no objections being made nor damages claimed, the board being of opinion that said road as laid out and surveyed will be of public utility. It is ordered that the report of the petition together with the plat and survey of said road be recorded and that said road be established. It is further ordered that the county clerk issue in the name of the board an order to the proper Owners of roads directing them to cause said road to be opened for public travel.

The resignation of Prof. E. Miller as a member of the board of examiners having been filed in the county clerk's office was presented read and on motion Ordered that said resignation be accepted.

The committee appointed July 10th 1891 to compare the orders turned over by the county Treasurer on that day and list the same presented the following report.
