And the Board of Commissioners being satisfied that the said petition is signed by twelve householders citizens of Douglas county and residing within the vicinity of the prayed for vacation and that the law has been fully complied with;

Order that Aaron Brundage, F. C. Tomberlin and L. W. Ingles be appointed Viewers and T. C. Darling Surveyor of said proposed vacation and that they meet at the place of beginning on 21st day of November A.D. 1876 and after being sworn proceed to the discharge of the duties of their several appointments according to law and make report of the proceedings herein at the next regular meeting of the Board. And it is further ordered that the County Clerk issue in the name of the Board the notice of this order the said viewers and Surveyor.
