Kurd, John Adams ^{and} Eli Wilson be appointed Viewers of the said road ^{and} that upon the day named in their notice together with the County Surveyor, they proceed to view ^{and} lay out said road according to law, giving to all parties a hearing and make due report of their Proceedings to this Board.

{ On the 5th day of April 1880, a petition was filed signed by Xavier Jordan ^{and} 18 others ^{and} presented to the Board praying for the Location of a Road described as follows: Begun at the quarter corner in the East line of Sec. 18, Town 15 Range 21 and running thence west one mile to the quarter corner in the West line of said Sec. 18, Town 15, Range 21. Said petition was accompanied with bond as required by law signed by Xavier Jordan as principal and J.B. Oniel ^{and} M.A. Oniel as sureties in the sum of one hundred Dollars, which bond was approved, ^{and} it appearing to the Board that the law had been substantially complied with, it was ordered that F.H. Baker, J.J. Bell ^{and} R.H. Pearson, be appointed Viewers of the said road ^{and} that upon the day named in their notice together with the County Surveyor they proceed to view ^{and} lay out said road according to law giving to all parties a hearing ^{and} make due report of their Proceedings to this Board.

In the matter of the Petition of {
Adam Kling ^{and} others for the
Location of a Road. }

{ On the 12th day of April 1880, a Road Petition was filed signed by Adam Kling ^{and} 30 others ^{and} presented to the Board praying for the Location of a Road described as follows: Begun at the S.E. Cor. of the S.W. 1/4 of Sec. 11, Town 14, Range 19 running west on the Section line or as near as practicable to the S.W. Cor of the S.E. 1/4 of Sec. 10, Town 14, Range 19. Said Petition was accompanied with bond as required by law signed by Adam Kling as principal ^{and} W.A. Marshall, Jacob Bowers ^{and} Michael Oswalt as sureties in the sum of One Hundred Dollars, which bond was approved ^{and} it appearing to the Board that the law had been substantially complied
