

In the Matter of Petition
of Frank Vogt & 36 others
to Locate & Vacate Road

On the 21st day of April 1884 a road petition signed by Frank Vogt & 36 others, was filed and presented to the Board of County Commissioners for the location and vacation of a road described as follows. Locate, "Commence at S.W. Cor. of S.E. 1/4 of S.E. 1/4, Sec. 34, T. 12, R. 21, South of the A. & S. P. R.R. track thence S 80 Rods to center of quarter section. thence west 80 rods to 1/4 Sec. line. thence S on said line about 35 rods. thence about 60 rods in a southeasterly direction around a bluff to the section line about 30 rods west of the S.E. Cor. of S.W. 1/4. thence west on said Sec. line about 100 rods. thence about 20 rods in a southeasterly direction around a bluff in the S.W. Corner of the S.W. 1/4 Sec. 34, T. 12, R. 21, to intersect a point in the section line road about 30 rods South of the said S.W. Corner.

Vacate, "Commence at S.W. Corner of S.E. 1/4 of S.E. 1/4 Sec. 34, T. 12, R. 21. thence west across the track of the A. & S. P. R.R. thence in a southeasterly direction to the section line road."

Said petition was accompanied with Bond as required by law signed by Frank Vogt & as principals and Chas. Pitta as surety in the sum of Cash and Expense, which Bond was approved and it appearing to the Board that the law had been substantially complied with, it was ordered, that Thomas Rayson, W. J. Kennedy and J. D. Villard be appointed viewers of the said road and that upon the day named in their notice together with the County Surveyor they proceed to lay out said road according to law, giving to all parties a hearing and make due report of their proceedings to this Board.

H. A. Cummings agh. } The Board having under consideration the Dedication of a Road by Saul Raber and H. A. Cummings it was ordered that said Dedication be accepted as follows. Beginning at a point in the road between Detroit and Clinton about 80 rods East of the center of Sec. 16, T. 13, R. 18, thence due East to the foot of the hill near East line of said Sec. thence in a north westerly direction as near to said hill as practicable to near the East line of said section. (all of said road to be located on said section) thence South to intersect said old road and to vacate said old road between the points of beginning and end of road. we hereby dedicate the land for the road above asked for, forever or so long as it may be used, for a public road and hereby waive all right to damages by reason of the location of said above mentioned road.
