

Lawrence, Kans. July 11th 1893.

The Board of County Commissioners met pursuant to adjournment in the office of the County Clerk.

Present: B. F. Hookinson, Chairman

and M. S. Winter, and the County Clerk.

In the matter of a Road
petitioned for by W. A. Dean
and others

The aforesaid petition of W. A. Dean as recorded in Commissioners Record, Page 527, being under consideration, the following action thereon was taken by the Board of County Commissioners: Upon due consideration no legal objections having been offered against the establishment or vacation of said road herein after mentioned, and believing the same to be of public utility, it is ordered that the Travers report of view and report and plat of survey be adopted, as follows: Begin at a stake 20 feet North of the $\frac{1}{4}$ sec cor in sec 28, T.13, R.18. thence Var 8° 50' E. East parallel with and 20 ft from the $\frac{1}{4}$ sec line 19⁰⁰ chains to a stake thence S 74° E 2⁰⁰ chains to a stake 20 ft South of the $\frac{1}{4}$ sec line. thence East parallel with and 20 ft South of $\frac{1}{4}$ sec line 58.80 chs to a stake 20 feet South of the $\frac{1}{4}$ cor between secs 27 and 28. (7⁰⁰ chs creek 10 fathoms wide South) (8⁰⁰ chs end of creek South). thence East parallel with and 20 feet South of the $\frac{1}{4}$ sec line in sec 27 - 46.07 chs to a stake 20 feet South of the center $\frac{1}{4}$ sec cor in sec 27, T.13, R.18, E. at intersection of road North and South. Vacate.

Begin at corner of sections 21, 22, 27 and 28, T.13, R.18. thence South on line between sections 27 and 28, 80⁰⁰ chains to corner sections 27, 28, 33 and 34. thence South 3⁰⁰ chains to a living tree 6" diameter in right bank of Rock creek a point in County Road No. 457.

And that said road first described be declared located & established as a public highway in accordance therewith, full record thereof to be made in the County Road Record and Book as Road No. and the Trustee of Clinton Township be notified to cause the same to be opened for public travel 40 feet wide.

petitioned for by D. M. Mifflin
and others

On the 8th day of July 1893, a Road Petition signed by D. M. Mifflin and 17 others was filed and this day presented to the Board of County Commrs of Douglas County, Kas. praying for the location and vacation of a certain road described as follows: "Begin at or near the $\frac{1}{4}$ sec cor between secs 7 and 8, T.14, R.18, where County roads cross each other on sec line. thence running E on said E & W road a short distance to creek bank. thence in a S by E direction across Rock creek at such point as said
