In the matter of a road as petitioned for by Frank Randall and others. Said petitioners being recorded on page -371 Vol. 6, of Commissioners record. Being under consideration the following action was had there only the Board of County Commissioners of Douglas Co Kas.-To Wit No legal objection being offered against the establishment of said road here in after mentioned and said Board believing, the same to be of public utility. It was ordered that Viewers report of view and plat of survey be adopted as follows-To Wit = Beginning in Palmyra Township-at the center of sec -25-T-14-R-20 Th-W-on sec line-160-R-to 1/4 sec cor Th west 1/4 sec line-80-R-3148-15-ft -Th west-80-R- Th -8-5-ft Th west -80-R-to intersect Baldwin Road said road to be Forty ft wide except -80-R² across the north end of the west 1/2 of the -8-E-1/4 of sec -26-14-20- With part last 50 feet thirty feet in width on account of a permanent fence

And that said road be located and established as a public Highway
 And the amount of \$65.00 was allowed By F.Frye as compensation for Damages incurred
