Schubert's Bill

Rejected.

The bill of H. M. Schubert & Son, filed July 13, 1905, for the sum of \$35.00 for funeral expenses of J. Hill, was rejected.

Cockins, & part of 10th conveyed by deed of gift from party of First Part to Party of Second Part) 1st. Begin at N. H. cor. of N. E. of Sec. 1-13-19, Th. E. 69 rds, S. 40 rds, N. 69 rds, N. 40 rds, to begin, except the S. part of said 10th conveyed by separate deed from the grantor to the grantee.

2nd. S. of E. 10th of S. E. of S. H. of Sec. 36-12-19.

3rd. Begin 40 rds N. 36 69 rds E. of S. H. cor. of S. E. of Sec. 36-12-19, thence N. 20 rds, N. 20 rds, E. 20 rds, S. 20 rds to begin.

4th. Begin at S. H. cor. of N. H. of S. E. of Sec. 36-12-19, Th. N. 4 ch., E. 17 1/2 ch., S. 4 ch., N. 17 1/2 ch. to begin. Reserved for streets 2 rds. wide off E. N. & S. Ends.
