

Douglas County, Kansas;

Section 1. That the Chairman & Clerk are hereby authorized to have prepared & execute under the seal of the County, twenty-eight (28) Refunding bonds of one thousand (\$1000.00) dollars each, numbered from one to twenty-eight inclusive, dated the first day of January, 1908, and payable the first day of January 1914, bearing interest evidenced by coupons attached, at the rate of five (5%) per centum per annum, payable semi-annually on the first day of July & January of each year, both principal and interest of said bonds to be payable at the Fiscal Agency of the State of Kansas in the city of New York.

Section 2. That the Bonds & Coupons thereto attached shall be in substantially the following forms, to-wit:

Know all men by these presents, that the County of Douglas in the state of Kansas is indebted to and for value received promises to pay to bearer, One Thousand (\$1000.00) Dollars, lawful money of the United States of America, on the first day of January A.D. 1914, with interest thereon at the rate of five (5%) per centum per annum, payable semi-annually on the first day of July and January in each year upon the presentation and delivery of the proper Coupons hereto annexed signed by the Chairman of the Board of County Commissioners and by the County Clerk. Both Principal & Interest of this Bond are payable at the Fiscal Agency of the State of Kansas in the City of New York. And the said county is hereby held and firmly bound and the full faith and credit of said County are hereby pledged for the prompt payment of this bond and interest at maturity.

This Bond is one of a series of twenty-eight (28) bonds of like date, & tenor, numbered from one (1) to twenty-eight (28) inclusive, issued by said county for the purpose of refunding a like amount of the out standing bonded indebtedness heretofore legally created by said County and which has been outstanding over two years. This Bond is issued & executed under and by authority of and in accordance with an act of the Legislature of the State of Kansas entitled "An act to enable counties, Municipal corporations, the Boards of Education of any city & School districts, to refund their indebtedness," which took effect March tenth, 1879, and all amendments thereto. Also by virtue of a resolution duly & legally passed by the full Board of County Commissioners.

And it is hereby certified & recited that all acts, conditions & things, required to be done precedent to and in the issuing of this series of Bonds have been properly done, happened and performed in regular and due form as required by law, and that the indebtedness which is refunded by this series of bonds is a constitutional, subsisting and legal obligation of said County and that neither the indebtedness so refunded nor this series of bonds exceed any constitutional or statutory limitation.
