1908. The Board of County Commissioners of Douglas County, Kan., met in adjourned regular session, There were present Gus H. Brune, J. C. Walton, A. C. Walter and the county clerk.

Bills Claims against the County were examined and allowed by the Board as per Allowance Record.

Tax Cancelled. The Board cancelled all of the 1907 personal tax of Char. S. Papp of Lawrence, excepting nineteen  $\frac{35}{100}$  dollars thereof.

The Board cancelled the 1907 personal tax on the organizations of "Sigma Chi Fraternity" & "Phi Delta Theta Fraternity".

Trustee Report L. M. Waller, Trustee of Wakarusa Township, made his annual report, which report was approved by the Board.

Rejected Bill The claim of M. W. Mair & Co. for 2257  $\frac{18}{100}$  dollars, which claim was filed Dec. 14, 1907, was rejected.

Prime Road Final In the matter of J. P. Prim road as petitioned for June 10-1907, and viewed July 11-1907, the Board accepted the report of the viewers. The viewers recommended that the road be located & vacated according to the field notes of the County Surveyor. The Surveyor's field notes are: Vacate: The East 20 ft. of road running South 160 rods, beginning at the N.W. cor. of the 1/4 Sec. of Sec. 28-14-18, Locate: The same on the East side of the S.E. 1/4 of Sec. 29-14-18.

On motion the Board declared the above road established as a public highway, and instructed the County Clerk to so notify the Trustee of Marion Township. The viewers also recommended that W. H. Baldwin be allowed One hundred forty nine dollars, as damages on said road, and the Board authorized its Chairman and Clerk to issue a warrant in favor of W. H. Baldwin for said amount (\$149.00).

Garrett Road Final In the matter of the J. A. Garrett road petitioned for on April 20, 1907, and viewed May 25, 1907, the Board accepted the report of the viewers. The viewers recommended that the road be located according to the field notes of the County Surveyor. The field notes of the Surveyor are: Beginning at the center of Sec. 15-T. 13-R. 20, thence West one  $\frac{1}{2}$  mile along the half section line. On motion the Board declared the above road established as a public highway forty feet wide, and instructed the County Clerk to so notify the Trustee of Wakarusa Township. The viewers also recommended that the following damages be allowed:— J. H. Garrett "estate" \$125.00, L. E. Jones \$35.00, Mary L. Everett \$70.00. On motion the Board instructed & authorized the Chairman & Clerk to issue warrants to said parties for said amounts.

Road Location. Owing to the J. B. Cunningham Road Dedication, which was accepted by the Board on Oct. 12, 1907, & which adds 16  $\frac{1}{2}$  ft. to the south side of the road along the N. side S.E. 1/4 of Sec. 2-12-18, the Board of Commissioners on motion vacated all that part of the old road which lies North of a line 20 ft. North of the following line:— Begin at the  $\frac{1}{4}$  Sec. cor. on the East side of section 2, T. 12, R. 18, thence S. 80° 30' W. 100 ft. to a point 16  $\frac{1}{2}$  ft. South of the  $\frac{1}{4}$  Sec. line. Thence N. parallel to  $\frac{1}{4}$  Sec. line 1963 ft., th. in a straight line 577 ft. more or less to the center cor. of Sec. 2-12-18. & instructed the clerk to so notify the Trustee of Decompton Township.
