A petition signed by J. C. Moore & 16 others was presented to the Board of County Commissioners, praying for the location of a road described as follows:— Begin at East Bank of Wakarusa Creek on half section line running East & West in Sec. 25-13-17, thence East to foot of Bluff, thence North Easterly to a point North of Carson Hicks' house on N.E. of Sec. 25-13-17, thence E. to point 20 ft. E. of Range line between Range 17 & 18, thence N. along the E. side of said Range line to the K.C.M.&O right-of-way, thence along the South side of said right of way to a point 20ft. S. of Sec. line between Sections 19 & 20 - T. 13 - R. 18, thence E. along S. side of Sec. line to Wakarusa Creek, thence across said creek, thence E. along N. side of said section line to a point about 7 ft. East of Sec. line between Sections 19 & 20 - T. 13 - R. 18, thence N. 130 rods more or less to Public Highway. Whereupon the Board decided to meet with the County Surveyor at the place of Beginning, on March 5-1908, 10 A.M., to view said proposed road & give all interested parties a hearing.

Steele and 25 others was presented to the Board of County Commissioners, praying for the location of a road described as follows:— Begin at East Bank of Wakarusa Creek on half section line running East & West in Sec. 25-T. 13-R. 17, thence E. to half sec. line, thence North on Carson Hicks' & E. G. Woodward, thence around the bank to sec. line on Carson Hicks' & E. G. Woodward, thence E. to range line, thence East along South side of sec. line to Wakarusa Creek, thence across said creek, thence East along North side of said section line to a point about 7 ft. East of Sec. line between Sections 19 & 20, T. 13 - R. 18, thence North 130 rods more or less to public highway. Whereupon the Board decided to meet with the County Surveyor at the place of beginning, on March 5, 1908 at 2 P.M. to view said proposed road & give all interested parties a hearing.
