are: Hallmark $\frac{3}{10}$ Moore across the Wakarusa in Western part of Clinton Twp.,
Eudora across the Wakarusa just West of Eudora City, Hill across Little
Wakarusa in Eudora Twp. The above bridges were bought according
to "Plan 1" "Case 2" as on file in County Clerk's office.
