Easterly direction to a point where the S. boundary line of the N.W. of S.E. of Sec. 16 intersects said South bank of said Mud Creek; N. to N.W. cor. of S.W. of S.E. of Sec. 16; thence S. 10 R.; N. 160 R. to point on West line of Sec. 16; S. 70 R. to the S.E. cor. of Sec. 17; West 200 R. along S. line of Sec. 17; N. 80 R.; West 120 R. to point on N. line of Sec. 17; S. 80 R. to S.W. cor. of Sec. 17; West 80 R. along N. line of Sec. 19; S. 80 R.; E. 240 R.; S. 80 R.; E. 160 R.; N. 80 R.; E. 160 R.; S. 240 R.; E. to S.E. cor. of S.E. of Sec. 21; South along the boundary line between Leavenworth County, Kansas, & Douglas County, Kansas, to the South bank of the Kansas River at low water mark; along South bank of Kansas River at low water mark in a Westerly & N. Westerly direction to the point of beginning. — Whereupon the Board of County Commissioners of Douglas County, Kansas, agreed to hear said petition on the 31st day of Dec. 1908, at 2 o'clock P.M.

In the matter of the O. G. Pedersen road as petitioned for Oct. 22 - 1908, and viewed Nov. 18, 1908 by the Commissioners of Douglas & Jefferson Counties, said road being on the line between said counties, the Board of Commissioners of Douglas County accepted the report of the viewers. The viewers recommended that the road be located according to the field notes of the County Surveyor forty feet wide. The field notes are: — Begin at N.E. cor. of Sec. 5 - T. 12 - R. 20; thence E. on North line of Sec. 4 - T. 12 - R. 20 forty one rods to intersect Lawrence road. On motion the Board declared the above road established as a public highway forty feet wide, and instructed the clerk to so notify the trustee of Grant Township. The viewers recommended that Sara T. D. Robinson be allowed \$10⁰⁰ damage on said road, and the Board authorized the chairman and clerk to issue a warrant amounting to \$10⁰⁰ in favor of Sara T. D. Robinson for damages by the O. G. Pedersen road.

In the matter of Herbert M. Brecheisen road as petitioned for April 15, 1908, and viewed May 21, 1908, the Board accepted the report of the viewers. The viewers recommended that the road be located according to the field notes of the County Surveyor, forty feet wide. The field notes are: — Begin 80 rods South of the N.W. corner of Sec. 13 - T. 13 - R. 20; thence E. 160 rods to the East line of the N.W. of said Sec. 13; E. 500 ft.; N. 4° N. 400 ft.; N. 88° E. 280 ft. to intersect the Hill road. On motion the Board declared the above road established as a public highway forty feet
