West on sec. line to gr. sec. cor. on N. line of sec. 24 Twp. 14 Rg. 18. Said road to be 40 ft. wide. The Board instructed the County Clerk to notify the Trustees of DeCompton and Kanwaka Townships that said road is to be established according to above. The Dividers recommended the following damages be allowed and authorized the County Clerk to issue warrants to the following persons:— Mrs Laura Hunters' Est. \$150⁰⁰, M. Hunters 150⁰⁰, M. C. Richards 150⁰⁰, A. Anderson 445⁰⁰, Mary Lydia A. Leslie 300⁰⁰, Geo. E. Miller 75⁰⁰.
