

May 10<sup>th</sup> 1913

The Board of Co. Commissioners met in adjourned regular session, with all members present.

It was ordered by the Board that Co. Clerk instruct Treasurer to allow Maria Brown to redeem following described property:-

Beginning 20 rods W of S E cor of S W  $\frac{1}{4}$  of N W  $\frac{1}{4}$  Sec 29 thence N 35 ft N to R.R. along R.R. to point due north of Beginning, S to Beginning; for sum of \$7<sup>25</sup> plus fees and advertising cancelling interest of \$2<sup>75</sup>.

The Board refunded to Mary Farringer \$4<sup>50</sup> of her 1912 tax on the following described property:-

Beginning N E Corner of N E  $\frac{1}{4}$  thence S 60 rods N to road N 175, N E along said road to Beginning on account of an erroneous assessment.

A Petition signed by Philip Ernst and 20 others was filed May 8<sup>th</sup> asking to be vacated, a certain road described as follows.

Begin N W corner of S W  $\frac{1}{4}$  of the S W  $\frac{1}{4}$  Sec. 12, Twp. 13 Range 20; thence N 85 degrees E, 11.30 chains, thence S 62 degrees E, 6 chains; thence N 77  $\frac{1}{4}$  degrees E 7.25 chains; thence S 82 degrees 30" E 3<sup>50</sup> chains thence S 66  $\frac{1}{4}$  degrees E 4.80 chains, thence S 38  $\frac{1}{4}$  degrees E 6.48 chains thence South 58 degrees E, 5 chains, thence S 24  $\frac{1}{2}$  degrees E, 3.08 chains to a stake in the bank of the Wakarusa Creek 6.25 chains N of the  $\frac{1}{4}$  Sec. corner between Sec: 12 & 13 of Twp 13 S of Range 20 E. Board set the 5<sup>th</sup> day of June as date for viewing said Road.

Claims against the County were examined and allowed as per Allowance Record.

Board voted to renew the Fire Insurance on County Court House and Structures for 3 years as follows;
