Whereas, the Board of Count. Commissioners of Douglas County, Kansas, are building a reinforced concrete bridge across the Kaw River at Commerce, Douglas County, Kansas, and, Whereas, one span of the said bridge crosses over the tracks of the Atchison Topeka and Santa Fe Railway, and, Whereas, the said Board of County Commissioners of Douglas County, Kansas, has requested the Atchison Topeka and Santa Fe Railway Co. to pay for the span of said Bridge, crossing over the tracks of the said Atchison Topeka and Santa Fe Railway Company, and,

Whereas, the said Atchison, Topeka and Santa Fe Railway Co. has offered to pay to the said Board of County Commissioners of Douglas County, Kansas, for the said span which crosses over their tracks, the total sum of Fourteen Thousand Three Hundred fifty-nine & 19/100 Dollars (\$14,359.19) which said sum includes the cost of said span, namely Twelve Thousand Nine Hundred Sixty-six Dollars (\$12,966.00) and the cost of raising said bridge one additional foot estimated at Seven Hundred Three & 70/100 (\$703.70) and an allowance of 5% for engineers expenses and other contingencies, estimated at Six Hundred Eighty-three & 49/100 (\$683.49) making a total of Fourteen Thousand Three Hundred Fifty-three & 19/100 (\$14,353.19).

Now therefore, be it resolved by the Board of County Commissioners of Douglas County, Kansas, in regular session at the Court house at Lawrence, Kansas on the 6th day of December 1915, that the Board of County Commissioners of Douglas County, Kansas, do accept the proposition of the said Atchison, Topeka and Santa Fe Railway Co. to pay to the said Board of County Commissioners of Douglas County, Kan. for the use of the special bridge fund, the sum of Fourteen Thousand Three Hundred Fifty-nine and 19/100 (\$14,359.19) with the understanding that the said Atchison, Topeka and Santa Fe Railway Co. will be relieved from
