line to the northeast corner of the west half of  
the southwest quarter of Section 14; thence south to the  
southwest corner of the west half of the southwest  
quarter of said Section 14; thence east on the section  
line to the northeast corner of the west half of the northwest  
quarter of Section 19, Township 13, Range 19; thence south to the  
southeast corner of the west half of the northwest quarter  
of Section 19; thence east to the southeast corner of the north-  
east quarter of said Section 19; thence north to the northeast  
corner of the southeast quarter of the northeast quarter of Sec-  
tion 19; thence due east to the southeast corner of the north-  
east quarter of the northwest quarter of Section 21, Township 13,  
Range 19; thence north to the northeast corner of the northwest  
quarter of said Section 21; thence east on the section line to  
the northeast corner of the northwest quarter of the northwest  
quarter of Section 22, Township 13, Range 19; thence due north to the north-  
east corner of the northwest quarter of the northwest quarter  
of Section 15, Township 13, Range 19; thence west to the south-  
east corner of Section 7 Township 13, Range 19; thence north  
to the northeast corner of the southeast quarter of the south  
east quarter of said Section 7; thence due west to the north-  
west corner of the southwest quarter of the southwest quarter

Section 12, Township 13, Range 18; thence due west to the southwest corner of the southeast quarter of Section 11, Township 13, Range 18; thence north to the northwest corner of the northwest quarter of the southeast quarter of said Section 11; thence west on the quarter section line to the northwest corner of the southwest quarter of said Section 11; thence north on the section line to the northwest corner of the northwest quarter of the southeast quarter of said Section 11; thence south on the quarter section line to the northwest corner of the southwest quarter of the southeast quarter of said Section 9; thence due west to the northwest corner of the southwest quarter of the southeast quarter of Section 9; thence south to the north-west corner of the northwest quarter of the northwest quarter of Section 16, Township 13, Range 18; thence west on the section line to the northwest corner of said Section 17; thence south to the southwest corner of the northwest quarter of Section 17, Township 13, Range 18; thence west on the quarter section line to the southwest corner of the northwest quarter of the northwest quarter of said Section 17; thence south on the quarter section line to the south-east corner of the northeast quarter of the northwest quarter of Section 20, Township 13, Range 18; thence due west to the southwest corner of the northwest quarter of Section 20; thence south on the section line to the southeast corner of the northwest quarter of said Section 20; thence west on the quarter section line to the southwest corner of the northwest quarter of Section 19, Township 13, Range 18; thence south on the section line to the place of beginning.
