

Rural High School

construction of a high school building

The boundaries of said proposed rural high school district, in which we, your petitioners, reside, are as follows:

commencing at the N.W. corner of NE⁴ of Section 6 Town 14 Range 20, thence south 4 miles then east 5 1/2 miles, then North 1 mile, then East 1/2 mile, then north 1 mile, then West 1/2 mile, then North 2 miles, then West 2 miles, then north 1 mile, then west 2 miles, then south 1 mile, then west 1 1/2 miles to place of beginning.

The amount of bonds to be voted for the construction of said high school building shall be \$10000.00 (Ten thousand dollars), Dollars, said bonds to be of the denomination of from One to Five Hundred Dollars each, bearing a rate of interest not exceeding six per cent per annum, and payable at a date not exceeding fifteen years from the date of their issue.

The said high school building shall be located at Three corners in the S.E. corner of the SW⁴ of Section 10 Town 14 Range 20 of Section 10 Township 14 Range 20 in Douglas County, Kansas, and shall be located and secured in compliance with section 6 of said House bill No. 36, of the Session Laws of 1915.

Accompanying this petition we hand your honorable body an accurate enumeration of the legal electors of the proposed rural high school district, taken and verified by an elector of said proposed district.

The said petition was signed by 208 signers.

Notice of Special Rural High School Election.**

Notice is hereby given that on the 1st day of June, 1916, a special election will be held within the proposed rural high school district at Vinland, Kansas, of Douglas County, commencing at eight o'clock a. m., and closing at six o'clock p. m., for the purpose of voting upon a proposition of establishing and locating a rural high school district and voting bonds for the construction of a high school building, said rural high school district to be comprised of the following territory: Commencing at the N. W. corner of N. E. 1 of Section 6 Township 14 Range 20, thence south 4 miles then east 5 1/2 miles, then north 1 mile, then east 1/2 mile, then north 1 mile then west 1/2 mile then north 2 miles then west 2 miles then north 1 mile then west 2 miles then south 1 mile then west 1 1/2 miles to place of beginning.

The electors in such territory will take notice that there will be submitted at said election the proposition for establishing a rural high school district of the territory described above, and the further proposition for the voting of bonds in the sum of \$10,000.00 (Ten Thousand Dollars) for the purpose of constructing a high school building upon the following described site: Three corners in S. E. corner of SW⁴ of Section 10, Township 14 Range 20, in Douglas County, Kansas.

That said special election is called and held under and by virtue of the provisions of House bill No. 36, as passed by the Legislature of the State of Kansas in the Session of 1915.

The Board examined the foregoing petition and found the same was signed by more than two-fifths of all the legal electors of the said proposed district; that the said proposed district contained not less than sixteen square miles; that said petition stated the proposed location of the school site and the amount of the bonds proposed to be issued.

Thereupon it was ordered that the petition be granted, and that an election be called and held on the first day of June, 1916, at Vinland, Douglas County, Kansas, within the proposed rural high school district; that there shall be submitted at such election the proposition to form a rural high school district from the territory named in the petition and to locate said rural high school on the site described in the petition, and to vote bonds in amount of Ten Thousand Dollars.
