

\$200,000 there be issued bonds of Douglas County, Kansas, in the
 Bond amount of \$200,000, same to be dated January 1-1922, to draw
 Resolution interest at the rate of 5 (five) per cent, payable semi-annually,
 both principal and interest payable at the office of the State
 Treasurer at Topeka, Kansas, \$100,000 of said bonds to be of \$500-
 denomination and \$100,000 to be of \$1,000 - denomination, one-tenth
 of said bonds to become due each year after date thereof,
 and that the full faith and credit of Douglas County, Kansas, be
 and the same is hereby pledged for the payment of said bonds and the
 interest thereon, and that the Chairman of this board be hereby
 authorized to sign said bonds and interest coupons thereto at-
 tached, and the County Clerk is hereby authorized to sign, attest
 said bonds and coupons with his signature and the Seal of Douglas
 County, and that said coupons may be so signed and attested by the
 facsimile signature of Chairman or Clerk. And further, that said
 bonds be advertised and sold according to law.

By motion duly made, seconded and passed, the board adopted
 the following resolution, to-wit:

Whereas, on the 8th day of September, 1921, the Board of County
 Commissioners of Douglas County, Kansas, determined by resolution
 that it was necessary to widen a certain road for the proper con-
 struction of a highway, to-wit: the road lying along the north line of the
 south one-half of the N.E. $\frac{1}{4}$ of Section 20, Township 13, Range 20, in
 Douglas County, Kansas, from the northeast corner of said south $\frac{1}{2}$ of
 N.E. $\frac{1}{4}$ of Sec. 20, Twp. 13, Range 20, east to the A. T. & S. F. Ry. right of
 way; and

Whereas, the owner of the land which it was determined in said resolution
 must be taken for widening said road, refuses either to donate or sell
 said land for the purpose herein mentioned; therefore, be it

Resolved, By the Board of County Commissioners of Douglas County,
 Kansas, in session this 12th day of October, 1921, that the road lying along
 the north line of the S. $\frac{1}{2}$ of the N.E. $\frac{1}{4}$ of Section 20, Township 13, Range
 20, in Douglas County, Kansas, from the northeast corner of said south $\frac{1}{2}$
 of N.E. $\frac{1}{4}$ of Sec. 20, Twp. 13, Range 20, east to the A. T. & S. F. Ry. right of
 way be widened twenty (20) feet to the south along its entire length,
 that said road and land shall be viewed by the said board on the 24th day of
 October, 1921, that notice of said view be published as provided by law in the
 official County paper, that notice of said view be served as provided by law on the
 owner of said land which is to be taken for widening said road, that record of said
 notice and manner of its service be placed of record on the journal of this board,
 that the County Engineer of Douglas County, Kansas, be directed to meet with
 this board for the view above mentioned, and that on the date set for said view
 or on the day following, this board meet at the place stated in the notice
