E. on the S. line of Sec. 31 & 32 to the qr. sec. cor. on the S. line of Sec. 32, thence in Twp. 13 S. of Range 18 E., S. on the qr. sec. line bet. Secs. 5 and 6, 4 and 9 to the qr. sec. cor. bet. Secs. 4 and 9, thence S. on the qr. sec. line to the center of Sec. 9; th. E. on the center line in Secs. 9-10 and 11 to a point 12.17 chains west of the center qr. sec. cor. of sec. 11 thence S. to the Wakarusa Creek, thence Easterly along the center line of said Creek to the S. line of the N. We further request your Honorable Body to find and declare said road improvements to be a public utility by order of your board and to make and order said improvements to be made and paid for and that all necessary action therefor be taken as prescribed in Senate Bill No. 576, House Bill No. 601 and Senate Bill No. 593 enacted into law by the Legislature of Kansas of 1917.
