Therefore, be it resolved by the Board of Commissioners of the city of Lawrence, Douglas County, Kansas;

That said road from the end of the present pavement on south Missouri street, Lawrence, Kansas, thence south and southwesterly along the west city limits of said city, thence following road numbered 35 and 74 to the west line of the said southeast quarter of section 36, township 12, range 19, Douglas County, Kansas, thence south along the road on said quarter section line to a point 120 rods south of the center of said section 36, be graded, curbed, guttered, paved or otherwise improved from the end of said pavement on Missouri stret to said point 120 rods south of the center of said section 36.

That said street and road be paved or otherwise improved for a width of twentyfive feet, including gutters, and that said paving be of concrete according to plans and specifications to be sporoved by the city engineer;

That in order to provide for the payment of the cost of said improvements, in accordance with the statutes in such cases made and provided, as may be assessed against the benefit districT to be created within said city of Lewrence, the number of assessments to be levied upon the lots, tracts or parcels of land situated therein shall be ten, and the said benefit district shall be all that part of the city of Lewrence, Kansas, embraced within the following boundaries, to-wit:

> All of Morgan Place, an Addition to the city of Lawrence, Douglas county; Kansas.

And be it further resolved, that upon the passage hereof by the Board of Commissioners of the city of Lawrence, Kansas, that this resolution be submitted to the Board of County Commissioners of Douglas county, Kansas, for its adoption and further comsideration and action, all as provided by chapter 92 of the laws of Kansas of 1921."
